COOKING FOR THE NHS

Maz and Simon Pennington continue with their amazing mission of cooking for the NHS – providing home-cooked lunches for the doctors, nurses and other staff in Basingstoke Hospital’s A&E Department. They hear from the staff that it has been mostly impossible to take a break and so without these meals they would be grabbing a bar of something from the vending machine in the waiting room or just going without. The meals are delivered hot and portioned so without risk of cross-contamination from serving implements etc, and with no need to take time to go to the canteen.

'We have now delivered 1,762 hot lunches to A&E over 39 days – 1,012 funded via Brighton Hill Community School, 378 by Cameron Gray, who walked a marathon in his back garden for the NHS, and 372 from the PayPal pool we have set up – much of which is from the residents of Cliddesden. Kites Up have also selected us as their method of donating their funds raised for the NHS, so the lovely rainbow NHS banners that you see around the village are feeding our local A&E staff. And ALL meals collected from us and delivered to the hospital by the excellent Lavender family – Mark and Paula. We could not do this without their commitment and efficiency. We know we're making a difference to the staff's day, every day. Their feedback is amazing!

'We want to carry on for as long as they need us, but we need help. Recent good news is that funding has been pledged by SSEN’s Community Grant Fund which will be a great help for a week or so. If you know of any other companies who might consider donating or match-funding us please send them our way. VILLAGE HALL UPDATE

It has been two months since we went into the COVID-19 related lockdown, with the Hall being closed since 23rd March. But we look forward to being able to welcome you all back in the not too distant future, so an update on what has been going on whilst all has been quiet.

Hall Improvements

As reported last month, prior to the lockdown the Trustees had already discussed and agreed the annual programme of improvements for the Hall, a programme we decided we could and should continue in order to take advantage of the Hall being completely unused for the time being. So, since the last newsletter article we have now completed the following:

- An upgrade to the carpark lighting, replacing the old bollard lights with something similar but now with much more economical and environmentally friendly LED lights, along with the placement of a few extra bollards in the far corners of the carpark. This is something we have been wanting to do for a long time and it will be interesting to see how much lighter the carpark will be on the darker nights. Photos of the project are on Facebook.
- Sanding and revarnishing of the main hall and meeting room floors. This is an annual check and spruce up which keeps the floor in good condition and always gets us good compliments, particularly from the more dance related hirers.
- Redecoration of the kitchen lobby and toilets. Again, this is an annual activity in line with our four-year rolling programme of redecoration which again keeps the Hall in a good condition resulting in even more compliments.

So we have been busy, but the key to these going ahead was an assessment that it is safe to do so in the current climate by ensuring that social distancing rules are adhered to with the prime focus being on people's health and well-being.

Some outstanding work includes upgrading the fire exit doors from the main hall, which have become more and more fiddly to close over the years, and possible repairs to the back roof fascia and some slipped tiles.

NEWS FOR JUNE *Hello from Claire!*



The Iris

Named for Iris, Goddess of the Rainbow, messenger to the Olympian Gods. It is seen to represent Faith, and Hope for a better tomorrow.

I sincerely hope that by the time you read this our 'better tomorrow' will be on its way.

They should be showing their faces in our gardens about now.

I have been reclaiming parts of my garden, and from conversations with almost everyone, we all seem to have a common 'enemy'

GROUND ELDER

That delightful ground cover plant that will fill every empty space, hide every plant, create an underground carpet of white roots, and reproduces itself from almost nothing. Even the rabbits won't eat it!

So, where did it come from? And what is it good for? And how can we get rid of it!!!!

Most likely introduced to Britain by the Romans as a salad leaf, Ground Elder is also known as Gout Weed, Bishop Weed or Jump-about.

Its Latin name is *Aegopodium podagraria*, and it is a member of the carrot family. It was used in the Middle Ages as a medicinal herb for the treatment of gout, hence the name Gout Weed.

Modern herbals still recommend Ground Elder as a treatment for gout, sciatica, rheumatism, haemorrhoids, inflammation and water retention. The leaves can be added to salads, where they give a nutty flavour, or cooked in butter like spinach.

There are various ways to get rid of this lovely menace –

Dig, dig, and dig again, lifting all your plants, washing roots clear of rhizomes, and replanting with clean new soil or compost;

Use a chemical weed killer – there are various on the market, please check instructions and use carefully;

Plant Mexican Marigold (L: *Tagetes Minuta*). The roots of this unassuming member of the Marigold family apparently kill the roots of perennial weeds. So will also work on bindweed (BONUS!).

Having found that the seeds of this wonder plant can be purchased online – I have found them at Sarah Raven so far, I may well give this wonder plant a go. Anything to save me another few hundred hours on my hands and knees!

NOTES FROM MAY PARISH COUNCIL MEETING

5th May 2020 Remote meeting via Skype. Thanks to Chairman for hosting

TO NOTE The Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020 - enable all local authority meetings to be held remotely, including allowing remote access by members of the public.

Parish Council chairman is Alan Tyler, re-elected for 2020/21.

Public session question submitted re dog walkers entering and walking in fields off Woods Lane where no public footpath. It was noted that when restrictions are lifted the Estate will visit the field and consider if any action is needed.

Year end accounts for 2019/20 agreed. See Parish Council website.

COVID-19 To record the Parish Council's appreciation and thanks to:

- everyone helping neighbours who need to isolate.
- Hazel Metz for her superb work in co-ordinating a Cliddesden community hub of support
- PC Reid for his support in encouraging social distancing - patrolling and keeping an eye out - and advising and responding.

The pond bench was temporarily removed by neighbours because of their concerns it was being used as a focal point for young people not self isolating. PC Andy Reid will be on call should any further problems arise. The Parish Council will consider where best the bench should be located - and if it should be re-located - once the 'lockdown' restrictions are eased.

Parish Lengthsman. Visit of 18th April (half day) - strimmed and tidied the pond grounds; cleared gully on Hackwood Lane above the Village Hall which was solid with silt, and cleared silt traps to the pond.

Next visit 17th June - 1. To clear vegetation overgrowing FP 1 beside the Church and Hoopers Mead.
2. Further investigation of gully Hackwood Lane (above Village Hall).

SID First SID is away for (second) repair - thought to be fault with the receiving antenna on radar as previously. Westcotec will advise when they are able to return to work. Simon Barker reported increase in speed during lockdown, notably by heavy vehicles and tractors.

PC Insurance Due for renewal 1st June, three-year tie-in expired. Clerk requesting comparison quotes.

Works to Trees All approval notices from the BDBC tree officer for TCA works are accompanied by advice on requirements to comply with the Wildlife & Countryside Act to protect nesting birds.

Neighbourhood Plan The Design Guides are being reviewed, and the Issues and Options document has been reviewed by Haines Consultancy. Reiterated and agreed the importance of keeping the process and documents as straightforward as possible.

TO RECORD The Parish Council's thanks to members of the Neighbourhood Planning Team who are putting in much time and effort.

Newsletter email Thanks to everyone who has supplied their email for a pdf copy. For May issue 133 copies were successfully emailed, and 100 copies printed.

MSA J6 M3 - Moto

17/03487/FUL Construction of a new Motorway Service Area
This application for a new Motorway Service Station on land south of the M3 at J6 is pending from 2017. Twelve new documents have recently been posted on the BDBC website hence further consultation. The Parish Council has responded - together with other PCs south of the M3 plus a response from transport planning consultants engaged by Winslade.

LEGISLATION PROTECTING NESTING BIRDS

'Bird Nesting Season' is officially from February until August (ref Natural England) and it is recommended that vegetation works (tree or hedge cutting) should be done outside of the nesting season. In reality the nesting period may start before this and extend beyond it. The busiest time for nesting birds is from 1st March until 31st July and of course varies according to species, etc.

The attached (right) and following is taken from the RSPB website...

'It will be an intentional act, for example, if you or your neighbour know there is an active nest in the hedge and still cut the hedge, damaging or destroying the nest in the process.'

The Wildlife and Countryside Act 1981 is the primary legislation which protects animals, plants and habitats in the UK



About the Act

Under the Wildlife and Countryside Act, a wild bird is defined as any bird of a species which is resident in or is a visitor to the European Territory of any member state in a wild state.

Game birds however are not included in this definition (except for limited parts of the Act). They are covered by the Game Acts, which fully protect them during the close season.

Basic protection All birds, their nests and eggs are protected by law and it is thus an offence, with certain exceptions, to:

- Intentionally kill, injure or take any wild bird.
- Intentionally take, damage or destroy the nest of any wild bird while it is in use or being built.
- Intentionally take or destroy the egg of any wild bird.

LEGISLATION COVERING BIN EMPTYING AND REMOVAL

Section 46 of the Environmental Protection Act 1990 empowers local authorities (BDBC/Hart) to require that:

- waste is sorted for collection as they specify
- bins are presented for emptying as they specify, and that
- bins are then removed from the highway.

In England, Section 46A makes non-compliance a civil offence subject to fixed penalties. **If you leave your bins out such that they are considered a 'nuisance' or 'detrimental to the locality' this will result in a written warning followed possibly with a fine.**

Environmental Protection Act 1990 C43 Part II Section 46 Receptacles for household waste

(1) Where a waste collection authority has a duty (section 45(1)(a)) to arrange for the collection of household waste from any premises, the authority may... require the occupier to place the waste for collection in receptacles of a kind and number specified.

(3) In making requirements under SS(1) above the authority may, as respects the provision of the receptacles

- (c) require the occupier to provide them – if he does not enter into an agreement under paragraph (b) above within a specified period; or
- (d) require the occupier to provide them.

(4) In making requirements as respects receptacles under subsection (1) above, the authority may, by the notice under that subsection, make provision with respect to

- (a) the size, construction and maintenance of the receptacles;
- (b) the placing of the receptacles for the purpose of facilitating the emptying of them, and access to the receptacles for that purpose;
- (c) the placing of the receptacles for that purpose on highways...;
- (d) the substances or articles which may or may not be put into the receptacles...;
- (e) the steps to be taken by occupiers of premises to facilitate the collection of waste from the receptacles;
- (f) the removal of the receptacles placed for the purpose of facilitating the emptying of them; and
- (g) the time when the receptacles must be placed for that purpose and removed.



Section 46A Written warnings and penalties for failure to comply with requirements relating to household waste receptacles: England

- (1) This section applies where an authorised officer of a waste collection authority in England is satisfied
- (a) a person has failed without reasonable excuse to comply with a requirement imposed by the authority under section 46(1), (3)(c) or (d) or (4) – ie a 'Section 46 requirement', and
 - (b) the person's failure to comply
 - (i) has caused, or is or was likely to cause, a nuisance, or
 - (ii) has been, or is or was likely to be, detrimental to any amenities of the locality.

(2) Where this Section applies, the authorised officer may give a written warning to the person....

(4) Where a written warning has been given in respect of a failure to comply that is continuing, an authorised officer of the waste collection authority may require the person to whom the written warning was given to pay a fixed penalty to the authority if satisfied that the person has failed to comply with the Section 46 requirement identified in the warning within the period specified.

WOODS LANE

ACCIDENT - AGAIN

This time a BMW 3-series crashed into the stone ballast on Woods Lane, 10.24pm Saturday evening 9th May. It was captured on CCTV camera and photos were taken the morning after.

The CCTV footage shows the car travelled three full car lengths in the space of one second prior to hitting the wall. According to BMW a 1995 3-Series Coupe is 14'6.5" (174.5in) or 4.433m long. So with a bit of maths and a margin for error..

$$3 \times 174.5'' = 523.5'' \text{ per second} \\ = 29.74 \text{ miles per hour.}$$

Arguably 30mph is too fast to be able to safely negotiate this section of road in any conditions at any time of the day. The footage also shows that the driver was braking prior to the crash so was likely to have been travelling faster further up Woods Lane.

There have been at least 10 similar accidents in the past few years and two in the last month. Basingstoke traffic police have been informed every time. They will attend if the car is blocking the road, or if a suspected drunk driver, but otherwise don't have time to attend damage-only car accidents. However the incidents should be on record and show the risk of a more serious accident.



In the past HCC wouldn't hear of the Parish Council's request to make Woods Lane 20mph, nor would they agree to an advisory '20 is Plenty' sign. Current policy seems to be only to allow 20mph areas near school entrances.

Data from the SID says that in the six weeks it's been on Woods Lane it only registered six speeders. There were more travelling at 25 to 30mph but the majority were below 25mph. The data set isn't huge and it was all over the autumn/winter period.

Speed limits and Speed Indicator Devices are unlikely to deter the minority who choose to try to race down Woods Lane and then miss

the turn. Means are needed to oblige them to slow down – and short of blocking the road...

The Parish Lengthsman will clear vegetation from the existing signs. New signage could better show drivers the danger well in advance and as they approach, and the Parish Council will put forward a case again for a 20mph limit. SID data showing that the majority of drivers travel below 25mph supports this request.

The Parish Council has written to Councillor Anna McNair Scott, HCC Highways and HCC Traffic Safety to request investigation, recommendation and preventive measures to be put in place.

MAINTAINING RIGHTS OF WAY 2020

During the summer HCC Countryside Services Access Group generally has a programme of vegetation cutting across the county. Contractors are tasked with cutting the 'Priority Cutting List' (PCL) of routes nominated as being locally important.

However, in view of the uncertainty surrounding Covid 19, the 2020 PCL contract will not go ahead. Parish Councils can request help from their Lengthsman – and willing volunteers! – to keep footpaths clear underfoot and clear of encroaching undergrowth. Please let the Parish Council know of any paths that need cutting. FP 1 beside the Church and Hoopers Mead will be cut by the Lengthsman on 17th June. Trees and hedgerows overgrowing the paths are landowner responsibility.

CLLR DIANE TAYLOR ANNOUNCED AS MAYOR FOR SECOND YEAR



Cllr Diane Taylor will be staying on as Basingstoke and Deane's Mayor for a second year, leading the civic life of the borough as everyone pulls together to respond to the challenge of coronavirus.

The decision makes history as Cllr Taylor will be the first BDBC Mayor to serve two consecutive terms since the council became a borough in 1978.

Cllr Taylor said: 'After much consideration and discussion with the Deputy Mayor and others, it was decided that the time isn't right for the handover as we continue to cope with the current pandemic. It will be a privilege to continue to serve as Mayor for this coming year – whatever that year brings.

Cllr Onnalee Cubitt, who was due to be Mayor for the 2020/21 council year, will stay on as Deputy Mayor until she is officially appointed as Mayor next May.



POLICE UPDATE

Dear Residents

I am pleased that no crimes of note have been reported in the Parish during the past month. However, in not too far Weston Patrick, seven crimes were

committed overnight of May 5th. During this night from midnight through to we suspect 3am, six homes had their garden sheds / outbuildings broken into, resulting in the theft of a leaf blower, chainsaw, saddle and bridles, numerous tools, bicycles, a motorcycle and equipment. In fairness most of the buildings required force, but some could have been made more difficult for the thieves. I ask residents who have CCTV or doorbell CCTV to please check for the period from 10pm on the 4th through to 6am on the 5th and see if anyone came into your garden, or any unusual vehicles can be seen. Please just give me a call direct if you find anything unusual.

The thieves will visit an area and will target such buildings that may be away from houses. They will have done research, they will check with Google earth to gain a layout of what buildings are where, access and exit routes. This may be a return visit to steal replacements for items they stole before. Someone would have been in the area possibly a week or so before looking about. This is why it is so important to record details of vehicles that are unusual to the area, the cold caller wanting to sell

something at the door, the feeble excuse 'can you tell me where Basingstoke is' etc.

Sadly times have changed, we do live in a fantastic area but this is now 2020 and no longer the 1950s. Residents do need to be more security aware and conscious that by the very nature of the place we live in, those of a criminal mind will come and take advantage. I always ask: 'Would you do what you do here if you lived in London?' Things like the unlocked shed, the unlocked car, the sat nav on full display, on occasions the unlocked house, car key left near windows, high quality equipment left in the garden.

We all need to up our game. Get good security, consider CCTV, sensor lighting, simple things like 'Beware of the dog' signs, decent gates that lock, record suspicious vehicle registrations, mark expensive equipment with your post code, record the serial number so if we find it we can return it to you and not the to thief as we can't prove it has been stolen.

When things return to 'normal' I will hold security and crime prevention awareness evenings, but in the meantime do your bit. Anyone can call me direct or leave a message for me with any registration numbers that you think is unusual, this is never a problem. Many thanks for your continued support. As an area we do well and especially during these difficult times which has brought out the best in supporting and helping neighbours and fellow residents.
