September and October Update.

Autumn has arrived in all its colour and glory, and the garden is heading for the winter. The spring and summer flowers and vegetables are finishing, but there is plenty to do preparing for the spring.

There are no meetings between the Wildlife Gardening meeting on September 25th and the AGM at the end of November

Bulbs are our winter preference, indoor pots of daffodils and hyacinth are always on the go, and then tulips outside in the tubs replacing the summer flowers, which in our case were mostly salvias and begonias. The best show previously has been from a mix of daffodils which flower first, and then tulips which come through to join in the display with the daffodils, before becoming the star of the show themselves. The bulbs need to be bought in as soon as possible to get the colours and varieties you want.

Outside naturalised bulbs come and go, we leave bulbs for as long as possible to keep flowering, increased by planting the indoor bulbs outside after they have finished to bloom again next year. Some varieties do well outside, but others fade away. Snowdrops first, then some grape hyacinth, on sunny days crocus, and in April wild bluebells in the woods make the show around the area.

Lawns have struggled through the dry summer, and so cutting in the autumn should only be a gentle trim, and then only when the grass can take it, aiming to leave it quite long to go through the winter. When I see or hear of **moss** troubles in lawns, apart from obvious shaded areas and wet patches, leaving the grass a bit longer helps it compete the moss out, preventing spores from establishing.



The AGM Date for your diary.

The Society AGM and Social is due to take place on Thursday November 27th at the Millennium Hall in Cliddesden, starting at 7.30pm, when the committee will give short reports on our activities in the Society during the past year, and members can bring forward ideas and suggestions for the future. The meeting is **mainly a Social evening** with refreshments so members can share gardening and other stories.

Seen in garden this year - Leaf Cutter bees.

In the folds of a garden umbrella Leaf Cutter Bees had been making cells for the larvae, using leaf circles cut from rose leaves. This is probably **Megachile centuncularis** as this species prefers roses. The rows of cells were fantastic constructions made by these solitary bees, each cell with an egg and a supply of pollen as food for the larvae when it hatches. It will overwinter in the cell and emerge next year.

The work involved is extraordinary, and all we can do is marvel at this wonderful insect.

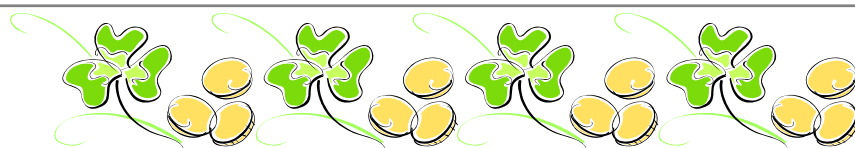

Hooray. It was a success. Thank you to all who came and well done to everyone who took part.



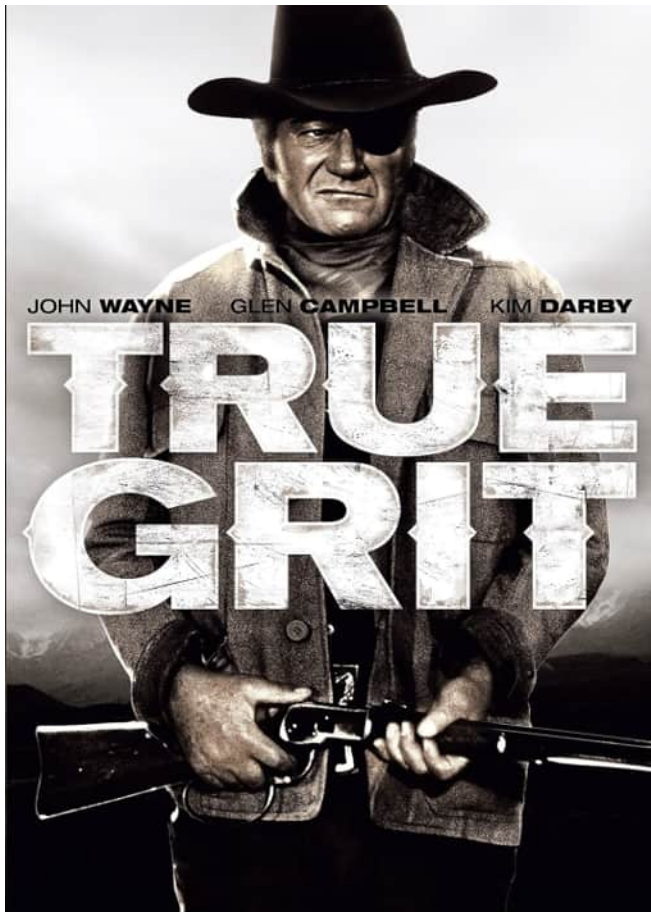

NOTES FROM SEPTEMBER PARISH COUNCIL MEETING

Meeting date 02 September.

Present Parish Cllrs, Clerk, PCSO Andy Jones, four members of public.

Police report from PCSO Andy Jones. 'Small groups of car drivers have been gathering on the corner of Northgate and Hackwood Lanes. New drivers gathering to show off their skills which unfortunately not very good. I was there last night (01 Sept) and gained extra intelligence. They have been warned but have not heeded. Traffic officer, specialist in traffic offences, will attend in an unmarked vehicle and evidence will be gathered for prosecution. This will move them on, if they have cars and a driving license after we have dealt with them. Action is needed; experience tells us that when we keep warning and giving advice, nothing changes; they learn to disregard. Otherwise very little to report for Cliddesden. 'Very few reports of hare coursing, the ground has been too hard for dogs; will be softer with rains, so watch this space. Please continue to report citing Operation Galileo and emphasise this to the operator.'

BDBC Local Plan Update Spatial Strategy: Upper Swallick see pg 7. STAnHD (Stand up for the North Hampshire Downs) action group will be in receipt of professional advice. For everyone to consider the detail of this site; the opportunity to respond to BDBC will be the new Regulation 18 public consultation to be published before Christmas.

Comment from the Chairman: 'To fight this allocation. If unable to prevent it, then to fight to get the best outcome for Cliddesden.'

BDBC Local Plan Update Spatial Strategy: Settlement hierarchy and housing allocations Cliddesden – in the current Local Plan – has a housing allocation of 10, as yet unmet due to the criteria required by Policy SS5.

For the Local Plan Update, a further allocation of 20 is waived due to the impact of proposed Upper Swallick site. The existing 10 remain but the criteria will change... *'In response to feedback from communities, the 2024 Reg 18 Plan proposed that all windfall development within settlements with SPBs will be able to count towards these targets... and therefore it is envisaged that where the housing requirements are low these can be accommodated on small windfall sites within SPBs over the 15 year plan period.'* (To bear in mind that the Settlement Boundary is tightly drawn; the changes to include all windfall sites does not cover sites outside and adjacent to the SPB.)

Neighbourhood Plan monitoring Every December BDBC, as the Local Planning Authority (LPA), publishes an Authority Monitoring Report (AMR) which sets out to assess the effectiveness of its planning policies over the previous year.

The document mostly focuses on the adopted BDBC Local Plan (2011-29) but Government guidance also encourages LPAs to monitor adopted Neighbourhood Plans. Thus the Cliddesden Neighbourhood Plan will be included in the AMR due to be published in December 2025.

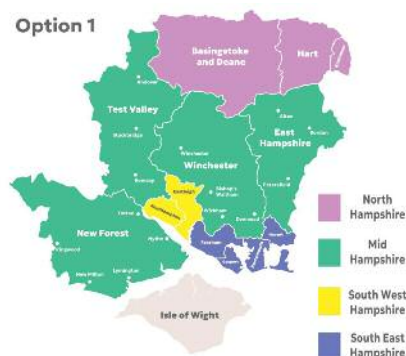

LOCAL GOVERNMENT REORGANISATION – MAJORITY PROPOSAL TO GOVERNMENT

A four-mainland unitary proposal including a North Hampshire Unitary comprising BDBC, Hart and Rushmoor continues to be supported by the majority of Councils who have now approved and submitted (for Government deadline of 26 Sept) a joint proposal entitled: *Close enough to be local, big enough to stay strong.*

Option 1 is favoured: Government will consult later this year.

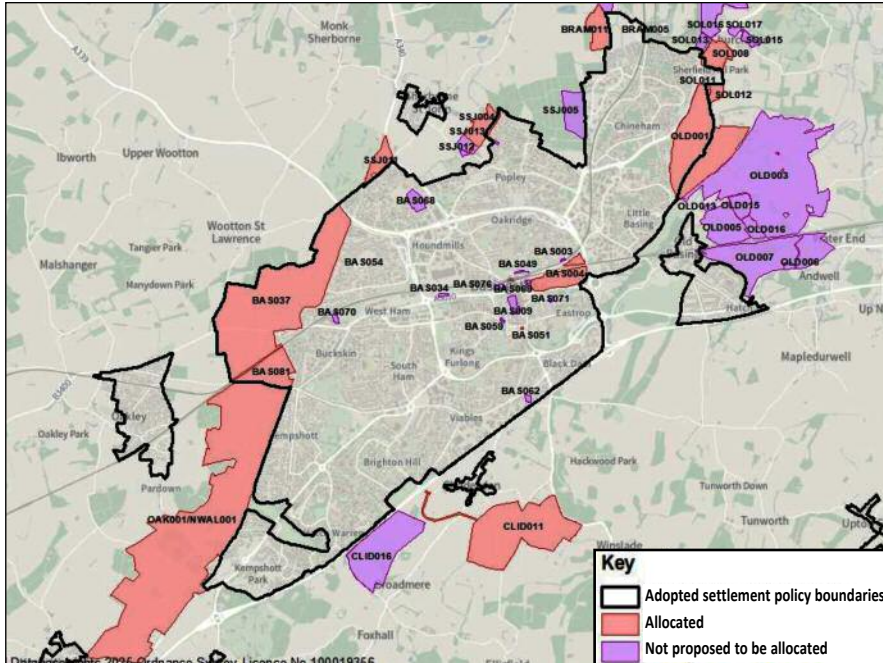


LOCAL PLAN UPDATE

BDBC published the first draft of its Spatial Strategy for the new Local Plan as part of the *Pubic Reports Pack* for Environment and Infrastructure Committee meeting of Thursday 04 September

The Environment and Infrastructure Committee meeting of Thursday 04 September was BDBC's first public debate on the new Spatial Strategy. Portfolio holder Cllr Andy Konieczko introduced the paper: 'it is fair to say this is a meeting none of us wanted to hold about a draft Spatial Strategy none of us wanted to produce'.

The new Spatial Strategy is a direct response to Government's imposed housing numbers – for Basingstoke & Deane an increase from 830 new homes per annum to 1,150.

On behalf of Cliddesden, Cllr Kate Tuck requested – if there has been housing development south of M3 – to look again at these sites. It seems Upper Swallick scores less favourably against criteria for development than Land South of Hatch Warren, yet finds itself allocated within the Plan. From Cliddesden’s perspective, damage to the village setting and landscape is so much greater by choosing Upper Swallick. The request is to look at what seems to be an inconsistent application of criteria.

Planning Policy Manager responded that Land South of Hatch Warren appears quite a big site but is quoted for 800 units so the yield significantly less. Because of where it sits right

next to the M3, is impacted heavily by noise, thus can only put houses on a small part of it. Quite different to Upper Swallick where looking at a Garden Village which will be more self sustaining. A matter of how would this smaller site be sustainable development, how would residents be able to access facilities? That is the key difference between the two.

Cllr Tuck asked if there is confidence that housing sites can be delivered from a statutory utility services perspective? Has BDBC received confirmation from these authorities that the overall level of development in the borough can be supported? Is BDBC using specialist engineering consultants to assist in assessing these infrastructure needs? And what measures are proposed if some sites become technically or financially unviable and Government housing numbers cannot be met?

Planning Policy Manager responded that many of these issues are caught up by the Infrastructure Development Plan; a lot more information will be published with Reg 18 consultation. But these conversations have been going on, and will continue to as the Plan develops. Water issues will be captured in the Water Cycle Study

(WCS); work undertaken so far has identified there are issues in terms of supply and treatment works.

Clir Konieczko noted that this new WCS was commissioned to evidence what providers need to do to sustain the level of housing growth we've been asked to provide. The first draft should be ready in time for Reg 18. Ultimately if this shows a water infrastructure deficit, then a case to go back to Government to say 'we can't deliver these housing numbers and here is the clear evidence why'. All have concerns about infrastructure delivery, but have to come up with very robust evidence to make a case.

BDBC's Head of Planning provided a recap and then outlined the Draft Local Plan process going forward...

'Council undertook a full draft (Reg 18) planning consultation in early 2024, before the Dec 2024 NPPF and higher housing figures. National policy requires we meet the new figures in full, which means it's been necessary to carry out an additional call for sites and consider how we might meet that target.

That has led us to propose a new Reg 18 consultation focussed on the new Spatial Strategy – which sets out what type of development will take place and where – and the details of proposed sites to be allocated for new homes and employment space.

'Committee this evening is considering the strategy and sites allocated, and recommendations to Cabinet. Cabinet will consider recommendations and providing they agree to the 'focussed' Reg 18 consultation, this will be published later this year supported by evidence documents published alongside it.

[NOTE] ‘Comments received from the previous (2024) Reg 18 consultation on all other sections of the Plan and Planning Policy remain under consideration. Following the new focussed Reg 18 consultation, all comments will be brought together to inform changes to be made for the Reg 19 Draft Plan due to be published for consultation mid 2026. Reg 19 only considers whether the Draft Plan is sound and legally compliant.’

Cllr Konieczko made it clear that have just over a year to get this Plan submitted to Inspector. If miss Dec 2026 deadline for submission will be required to navigate a new planning system. No-one knows details of this but everyone expects it to give local authorities even less of a say over the local plan making process.
